Furthermore, NZTR reserves the right to withdraw your line of credit, refuse nominations for horses and place you on the NZTR Arrears List until the outstanding amount is received in full. - I accept appointment as Racing Manager on behalf of the owners/lessees (as applicable) for the abovementioned horse and agree to act on the owners'/lessees' behalf in all matters, as required under Rules 425-430, 1401-1437 (specifically 1429-1431 Accountable Person) of the New Zealand Rules of Racing, including the payment of NZTR Owners Settlement Accounts. I confirm the information provided on this form is entirely correct. I acknowledge that the provision of any false, misleading or inaccurate information on this form may result in me being prosecuted under the Rules of Racing or otherwise.
