LICENSING & REGISTRATIONS

CPD Requirements

Another reminder to all Class A Trainers that the Human Resources and Immigration CPD module must be completed to be eligible for licence renewal for the 2025/2026 season. A big thanks to those trainers who have completed this requirement. Those who have not completed the CPD requirements will not be sent a licence renewal notice. Please contact Hayley Thistoll (Education Coordinator) for those needing assistance.

Colour Renewals

Colour registration renewals commenced at the end of May. This process is automated, and all owners and trainers who hold colours will receive an email containing their Renewal Number, Entity ID, and a link to complete their renewals online for the upcoming five-year period.

We are currently investigating improvements to the colour renewals system and will endeavour to implement these in due course. In the meantime, colour renewals will continue to be processed using the existing system.

Licence Renewals

Licence renewals were rolled out earlier this week, and all licence holders should have received their renewal notice by now. If you have not received a notice, please contact NZTR.

- No additional downloads will be required, as updates will occur automatically in the background.
- Once payment is received, the Digital Licence ID expiry date will be updated within 24 hours.
- On 1 August, the new season details will automatically update on the Digital Licence ID.
- If a licence renewal is not completed by this date, the licence will be automatically removed from the holder's device.

TRACKS AND INFRASTRUCTURE

Awapuni

Renovation work at RACE Awapuni is ongoing with the track having been undersown and fertilised, as well as decompaction work completed with machinery. Liam O'Keeffe will undertake a track inspection Monday 2 June, with a further update communicated to the industry following this inspection.

Ōtaki

NZTR and the Ōtaki-Māori Racing Club can confirm that the Ōtaki track was subject to intentional turf damage, which compromised the safety of the racing surface. In response, security cameras have been installed and are now fully operational.

Since the incident, significant remedial work has been undertaken to support the safe return of racing. An inspection conducted on 22 May by NZTR, the RIB and the Regional Track Advisor confirmed strong progress, with healthy turf regrowth aided by favourable weather conditions. A further assessment is scheduled for the week commencing 2 June. NZTR will communicate an update to the wider industry following this inspection.

Hawkes Bay Racing

As noted in a release Wednesday 21 May: Pending approval by the NZTR Board, we can confirm that work will progress on a partial re-cambering of the bends leaving the home straight (1600m & 1400m) of the Hastings racetrack.

Notwithstanding any unforeseen circumstances, this significant, expert-led investment will allow for a safe and confident return to racing in Hawke's Bay for spring 2026. This work is essential to ensuring a sustainable future for racing in the region.

In parallel, further planning is underway to determine the long-term vision for racing in the wider Hawke's Bay area. NZTR and Hawke's Bay Racing expect to share more detailed updates with members and the public in July.

We would like to thank our East Coast racing clubs who continue to work together to shape a strong and sustainable future for the industry and the community. We look forward to a return to racing in the Hawke's Bay Region.

Acknowledged Retrainer Network

We would like to acknowledge the racing connections that ensure their horses arrive in the right condition to start work at the retrainers. Recently we have had two horses arrive (from one trainer) with a fresh set of shoes, a dental in the last 10 days, and in good body condition. Unfortunately, this is not the case across the board and the retrainers are still expected to take on horses that are not fit to start work.

Welfare Cases

The team is currently supporting 5 horses that require support through the SPCA. A joint venture between the Welfare Team and the RIB saw Tracey Oakes and Anna Palmer attend the Wellington SPCA centre to talk to the new intake of SPCA Inspectors about how our agencies work together and what we do in the welfare space to ensure a good life for our horses. WELFARE

Reinstatement to Racing for horses that have had a 12-month break

This is a new developing policy that NZTR are currently working on to ensure the best welfare outcomes for our horses. We need to ensure that all horses returning from long layoffs or previous retirement are ready for racing as the risks are potentially damaging to racing's horse welfare and our continued social licence. Having this measure in place requiring a Veterinary Clearance and a Trial to Stewards satisfaction is a positive step forward and this policy will be further developed and consulted soon. This policy brings NZ into line with several other international jurisdictions.

EMRP - Raceday and Trial fatalities

The recent meeting of Raceday Veterinarians, RIB, HRNZ and NZTR discussed the process currently in place for racedays and future improvements. Having the crematorium in place will alleviate some of the difficulties that clubs face when a fatality occurs. The process for this is currently being drafted. The crematorium is nearly fully functional and is on track to open by the end of June.


The complaints will be taken seriously, with the priority being the rights and wishes of the complainants.

RACING INTEGRITY BOARD UPDATE

Lightning Policy

In consultation with the Codes the RIB is finalising a RIB operational policy to be adopted when there is a risk of lightning at a race or trial or other activity that is regulated or overseen by the RIB. This policy, and in particular the "30/30 Rule" mirrors those of Racing NSW and Racing SA (as examples). In general, the "30/30 Rule" is a widely recognised guideline for lightning safety across various outdoor activities. This rule advises individuals to seek shelter if the time between observing a lightning flash and hearing its corresponding thunder is 30 seconds or less, indicating that the lightning is approximately 10 km's away. Furthermore, it recommends waiting at least 30 minutes after the last thunderclap before resuming outdoor activities to ensure the storm has moved a safe distance away.

Though lightning events may be relatively infrequent in New Zealand, the consequence of a lightning strike is no different, and we recognise the heightened risks on horseback or when assembling in or near starting gates/boxes etc. Clubs may each consider adopting the policy for daily operations.

RIB Operational Changes - Swabbing

The RIB has reviewed the operational processes for race day swab collection. While collection, bagging, confirmation and dispatch of samples will continue to be undertaken by Swabbing Officials with no change in their handling processes, they will no longer be supervised by Investigators. This realignment recognises the competence of Swabbing Officials and is an efficiency measure to allow Investigators to focus their skills on their primary responsibilities and imperatives.
