

Application to Reinstate an Ineligible Horse for Racing Purposes

A horse that has been retired from racing or has not raced/trialled in a 12-month period must apply to NZTR to reinstate the horse's eligibility to race. The horse will be required to have a veterinary clearance for racing and successfully barrier trial to steward's satisfaction before it will be cleared for racing.

Please ensure that this form is completed accurately, and all information requested is provided.
An incomplete form will be subject to a processing delay.
